## Terms and conditions for seasonal rental

### 1. Registration

Seasonal rental partners can register using the official order form or by email. Rent a Bike will send a definitive confirmation in writing.

Rent a Bike AG will provide the contractual partner with the specified vehicles for use during the rental period. The vehicles remain the exclusive property of Rent a Bike AG during the rental period. After the rental period, the vehicles can be taken over by seasonal rental partners.

### 2. Delivery dates

The delivery dates requested in the registration form are not binding for Rent a Bike. Seasonal rental partners will be notified by telephone prior to delivery/collection. The dates provided are requested dates and will be scheduled as far as possible.

### 3. Obligations of the partner

E-bikes and accessories must be kept in good condition and made available to the public for tourist rental throughout the season. The partner must fulfil their obligations in accordance with the manual.

### 4. Services provided by Rent a Bike AG

The services are defined as described in the seasonal rental offer. Rent a Bike delivers the e-bikes professionally inspected and instructs the partner on site. Marketing services are included for all seasonal rental partners.

### 5. Storage of vehicles / vehicle maintenance and repair

The contractual partner undertakes to store the vehicles in closed rooms. The contractual partner is liable for theft with an excess of CHF 500.00.

Regular vehicle maintenance is the responsibility of the contractual partner. The contractual partner undertakes to maintain and service the vehicles in perfect condition.

Repairs are at the expense of Rent a Bike AG. The contractual partner is obliged to have all repairs carried out professionally by the designated Rent a Bike service centre. This does not include, for example, damage caused by improper use/falls. In the event of theft, other loss of equipment or defects, please contact us directly.

### 6. Return / missing equipment

Missing equipment will be invoiced to the partner at the end of the season at its current value. If the equipment is dirty when it is collected, a cleaning fee of CHF 50.00 per e-bike will be charged.

## 7. Payment

The costs for the seasonal rental, delivery and any options ordered will be invoiced after delivery.

The rates stated in the registration form apply. The payment term is 30 days.

Rent a Bike AG will issue a corresponding invoice in good time.

## 8. Liability and protection package

The partner is fully liable for the equipment rented from Rent a Bike AG and for its use. Rent a Bike AG accepts no liability in this regard.

The seasonal rental fee includes a comprehensive protection package, which covers the following services:

- Unforeseen and sudden damage and destruction of a rented bike as a result of an accident or fall during use.
- Damage, destruction or loss of a rented bike as a result of attempted or completed theft.

The following **excess** applies in the event of damage:

- Accidents: 10% of the damage costs, but at least £100.00 per incident
- Theft incidents: £500.00 per incident

## 9. Assistance

Coverage includes restrictions on the roadworthiness of the rented bike as a result of a breakdown, accident or empty battery. A deductible of CHF 100.00 per e-bike will only be charged if the battery is empty. A detailed list of the services included and exclusions will be provided subsequently.

## 10. Place of jurisdiction

Exclusive place of jurisdiction: Willisau. The rental agreement is subject to Swiss law.
