## **AGB Seasonal Rent 2024**

### **1. Registration**

Seasonal rental partners use the official order form for registration. Rent a Bike AG reserves the right to consider only those applications that meet the criteria set out in the manual and the distribution of territories. A definitive acceptance of partners will only take place with the written confirmation of Rent a Bike.

Rent a Bike AG provides the contract partner with the defined vehicles for use during the rental period. The vehicles remain the exclusive property of Rent a Bike AG during the rental period. After the rental period, the vehicles may be taken over by seasonal rental partners.

### **2. Delivery dates**

The delivery dates requested in the registration form are not binding for Rent a Bike. Seasonal rental partners will be notified by telephone prior to delivery/collection. Dates are requested and will be scheduled as far as possible.

### **3. Duties of the partner**

E-bikes and accessories are to be made available to the public for tourist rental in a well-maintained condition throughout the season. The partner shall fulfil his obligations according to the manual.

### **4. Services of Rent a Bike AG**

The services are defined as described in the seasonal rental offer. Rent a Bike delivers the e-bikes professionally checked and instructs the partner on site. Marketing services are included with all seasonal rental partners. Services according to the manual.

### **5. Vehicle storage / vehicle maintenance and repair**

The contract partner undertakes to store the vehicles in closed rooms. In the event of theft, the contractual partner shall be liable for the deductible of CHF 500.00.

Regular vehicle maintenance is the responsibility of the contract partner. The contracting partner undertakes to care for and maintain the vehicles in an impeccable manner.

Repairs shall be at the expense of Rent a Bike AG. The contract partner is obliged to have all repairs carried out professionally by the defined service point of Rent a Bike. Excluded from this are e.g. damages caused by improper use/fall. In the event of theft, other loss of material or defects, please contact us directly.

### **6. Return / missing material**

Missing material will be invoiced to the partner at the current value at the end of the season. If the material is dirty when it is collected, a cleaning fee of CHF 50.00 per e-bike will be charged.

## 7. Payment

The costs for seasonal rental, delivery and ordered options will be invoiced mid-season. The rates in the registration form apply. The payment period is 20 days. Rent a Bike AG will issue a corresponding invoice in enjoyable time.

## 8. Liability and protection package

The partner is fully liable for the material rented from Rent a Bike AG and for its use. Rent a Bike AG rejects any liability in this regard.

Included in the seasonal rental is a comprehensive protection package which includes the following services:

- unforeseen and sudden damage and destruction of a rented bike as a result of an accident or fall during use.
- Damage to, destruction or loss of a rented bike as a result of attempted or completed theft.

The following **deductible** will be applied in the event of a claim:

- Accident events: 10 % of the damage costs, but at least CHF 100.00 per event
- Theft incidents: CHF 500.00 per event

## 9. Assistance

Restrictions on the fitness to ride of the rented bike as a result of a breakdown, an accident or an empty battery are covered. A deductible of CHF 100.00 per e-bike will only be charged in the event of an empty battery. A detailed list of the included services and exclusions will be sent subsequently.

## 10. Place of Jurisdiction

Exclusive place of jurisdiction: Willisau. The tenancy is subject to Swiss law.
